## Memorandum

**Subject:** Licensing Report

---

- New applications have increased by approximately 200 for March over January and February 2021 totals. In addition, new applications have increased by approximately 100 over March 2020.
- Coming off the heels of an ice storm and a current decrease in staff availability the agency has been challenged with increased processing times for new applications. Licensing has begun collaborating with Enforcement staff to reduce new application processing time.
  - This work includes performing new application background checks concurrently or prior to licensing data processing and shifting some of the data entry to enforcement staff.
  - The expected results are more streamlined agency communication with applicants and faster licensure.
  - This work also levels out the workflow from Licensing to Enforcement.
- Collaborating with Education to review and update the “Guide to becoming a licensed contractor”.
- Reviewing and updating license applications to eliminate common pitfalls for contactors. Expected outcomes are:
  - Reduced volume and length of phone calls regarding new applications
  - Increased satisfaction with new application process
  - Shorter turnaround due to fewer incomplete or incorrect applications
- Collaborating with IT and Education to review license card format and shift printing/distribution to the State print plant. Expected outcomes are:
  - Uniform design for all license card types
  - Cost savings by shifting process to the print plant (this includes, printing, stuffing, supplies, postage and overall reduction in agency labor costs) Increased availability of Licensing staff to outside customers (because they are not stuffing envelopes)

Now 4 months into 2021, CCB's Education section has made strides in outreach and contractor training.

#### Webinar Update:

\*as of the writing of this memo, three more webinars are scheduled for later this month. April's numbers will increase.

\*\*this is approximately double the number of contractors reached in live classes in all of 2019

#### Outreach:

- CCB recently released a new homeowner newsletter, which was delivered to over 9,000 recipient emails. The homeowner newsletter is attached to this board memo.
- The feature article in the homeowner newsletter was picked up by the *St. Helens Chronical*. This is the second (known) time that an article in the homeowner newsletter was picked up by small newspaper. We are now exploring new ways to expand the reach of the newsletter through media outlets.

The Education section is currently working on a new online course that contractors can access through their online services account. We're also actively sorting through the online classes to weed out old courses that may need to be updated. Ideally, we'd

like to complete two online courses this year as we were unable to complete an online course last year, and we try to do this work annually.

We're currently scheduling at least 3 live webinars per month, and plan to continue to schedule three per month as long as enrollment numbers continue to be high. Nearly every class this year has been fully booked by the day of the webinar.

## Protect Yourself From Paving Scams

It happens every year: scammers travel from state to state claiming to offer paving services to unsuspecting homeowners. These scams happen all over the country. A simple search for the term "paving scams" in your web browser will turn up articles from east coast to west citing occurrences that all sound eerily similar.

### *What happens?*

Scam artists go door-to-door, often claiming they have leftover supplies from work performed elsewhere in the neighborhood. After making a lowball offer to pave the driveway, they start work immediately, giving homeowners no time to reconsider.

They take money up front and perform shoddy work with low-grade materials. They're smooth-talking, forceful and often work in teams. Usually they return to demand more money through intimidation. Once the job begins, homeowners feel afraid to say "No, I won't pay more than the agreed upon price."

When the work is finished, they cash the check at the nearest bank, within minutes of pulling away from the property.

Their work crumbles quickly, or washes away with the first rain.

It can happen anywhere.





A recent article in the Bend Bulletin illustrates the work of one paving scammer that defrauded homeowners in Klamath, Deschutes and Lane counties. This textbook scammer walked away with thousands of dollars from homeowners who never received the services they paid for. You can protect yourself. With information about how these scams work, you can make informed decisions that can help you avoid scams.

## What Are the Signs of a Paving Scam?



Paving scammers have a formula that works, and they often don't deviate far from that formula. While their tactics are effective for unsuspecting victims, you can spot the signs of a scam if you know what to look for.

**A deal you can't refuse.** It's hard to walk away from an amazing opportunity, but you know what they say: If it sounds too good to be true, it probably is.

**"Limited time only!"** This is a pressure tactic that sometimes leads homeowners to make on-the-spot decisions without doing their homework. Do not be pressured by people soliciting door-to-door, especially for paving services.

**Not a lot of equipment.** Legitimate driveway paving requires equipment that pavers may leave in a conspicuous place or at the worksite. Meanwhile, paving scammers use surprisingly little equipment and have far less material than you would expect for the size of the job.

**Out-of-state plates, no CCB# on signage.** Often, these scam artists use magnetic signs to mark their trucks, which they then remove or replace between states. By contrast, contractors licensed with the state of Oregon should include their CCB number on any vehicle signage.

**Want to use "leftover materials".** Paving scammers often claim they have leftover materials from a job done just down the street. You may even have noticed their crew at a neighbor's house, which seems to lend credibility to their story.

## How Can You Reduce Your Risk of Becoming a Victim?

All homeowners have some level of risk of being scammed. Remember, if it wasn't an effective tactic, scammers wouldn't be doing it. Still, you can decrease your risk by adopting some of the habits below.

- **Make yourself wait.** Don't be pressured to act immediately. Wait a few days. Give yourself time to make an informed decision. If the contractor insists you must make a decision now, this is a red flag. Say no.

- **Check their CCB number.** Paving contractors must be licensed by the CCB. Get their CCB number and check the number to be sure it's active. Make sure the name of the business matches the contractor's business name.
- **Do your homework.** If you need driveway paving services, interview multiple contractors before choosing a professional you trust. Get references. Compare bids. Remember, driveway paving can be costly. Be cautious of bids that are dramatically lower than the others, and make sure it's an apples-to-apples comparison.
- **Get a family member's opinion.** Don't make big decisions alone. Talk to a family member who may offer a different perspective.

As we closed out the first calendar quarter of 2021 (7<sup>th</sup> biennial quarter) I will recap the quarter and outline a few changes for the Enforcement Programs.

### DRS Processes

- DRS Correspondence project is now complete and “paperless”
- Complaints filed are still below the year ago figures

### Compliance Process

- Compliance cases are also still below the year ago quarter and holding steady
- New applications sent for screening hit a record level in March

### Field Services Process

- Field site visits are slightly above one year ago
- Field reports are also very close to one year ago figures

Bob’s replacement has been hired and I am pleased to welcome Allie Platz to the Enforcement team!

The Compliance section is charged with evaluating evidence to substantiate violations of ORS 701 and OAR 812. Violation tips and complaints come from the Field Investigation Section (FIS), Dispute Resolution Services (DRS), on-line tips, phone tips as well as from local jurisdictions. The Compliance staff verifies a violation and determines whether an administrative warning or civil penalty is warranted. When warranted Compliance staff has the ability to enter into settlement agreements on behalf of the agency which is usually for a first time offenses. Respondents have a choice of entering into a settlement agreement which is conditional or opting to have an administrative hearing where the Compliance staff would represent the agency as a lay representative.

Dispute Resolution Services  
7th Quarter - 2019-2021 Biennium  
January 1, 2021 - March 31, 2021**

Dispute Resolution Services provides a process designed to resolve construction disputes. It is available to persons or businesses alleging that contractors have breached a contract, performed improper work, or failed to pay for work performed or materials supplied. This service involves a mediation service to try to keep disputes out of the court system. If the dispute must be resolved by a court and the consumer who filed the complaint receives a court judgment but the contractor fails to pay the judgment, then the consumer has access to the contractor's bond for payment. Owners of construction companies are prevented from starting new construction businesses until all amounts awarded in the judgments are paid in full. When both parties participate in the mediation process, over 60-70% of those mediations result in a settlement agreement.

## Construction Contractors Board Field Investigation Section Quarterly Report for the 2019-2021 Biennium

Knowing that unlicensed and illegal construction activity is bad for consumers and legitimate contractors, the CCB established the Field Investigation Section in 2007, to provide statewide coverage and immediate response to complaints of unlawful activity in the construction industry. The staff includes 10 Investigators, each assigned to their own district in the state, where they are positioned to respond to complaints of illegal construction activity and conduct random checks of local construction sites. Sweeps are executed to find those involved in unlawful construction activity. The Field Investigation Section also participates in joint investigations with other state, county, and city agencies, some of which lead to the filing of injunctions or criminal charges.
