RE: TSP Guidelines Audit and Update Strategy – DRAFT¹

INTRODUCTION

The Department of Land Conservation and Development (DLCD) updated Oregon Administration Rules (OAR) Chapter 660, Division 12, also known as the Transportation Planning Rule (TPR), in 2022. The rulemaking that updated the TPR is known as the Climate Friendly and Equitable Communities (CFEC) rulemaking. The purpose of the CFEC rulemaking was to better align the state's transportation planning with its long-term climate pollution reduction goal. The rulemaking primarily focuses on Oregon's eight metropolitan areas, requiring changes in transportation planning that support Oregonians' access to transportation options that would reduce single-occupancy vehicle reliance. The added requirements in metropolitan areas² include:

- Conducting multimodal inventories of the local transportation system.
- Prioritizing walking, biking, and transit investments to access destinations.
- Planning transportation demand management programs and services.
- Identifying investments to support greater development in transit corridors and downtowns.
- Planning for and managing parking.
- Identifying investments and planning for electric vehicle charging infrastructure.
- Conducting equity analyses to understand impacts of the transportation system and identifying strategies to minimize impacts on underserved populations.
- Selecting and using system performance measures that further community livability goals.
- Regularly monitoring and reporting progress related to increasing equitable outcomes for underserved populations and decreasing climate pollution.

As part of the CFEC rulemaking, cities and counties with a population greater than 5,000 and that are within one of the state's metropolitan planning organization

² "Metropolitan areas" are defined in the TPR as the local governments that are responsible for adopting local or regional transportation system plans within a metropolitan planning organization (MPO) boundary. This includes cities, counties, and, in the Portland Metropolitan Area, Metro.

boundaries (excluding Metro) will need to define Climate Friendly Areas (CFAs). Per DLCD's website, a CFA is

"...an area where residents, workers, and visitors can meet most of their daily needs without having to drive. They are urban mixed-use areas that contain, or are planned to contain, a greater mix and supply of housing, jobs, businesses, and services. These areas are served, or planned to be served, by high quality pedestrian, bicycle, and transit infrastructure to provide frequent, comfortable, and convenient connections to key destinations within the city and region."

This project is focused on updating ODOT's Transportation System Plan (TSP) Guidelines based on the updated TPR that incorporates the CFEC rulemaking. The TPR includes requirements that affected local jurisdictions must comply with when creating a new TSP or updating their existing TSP. The TSP Guidelines provide a step-by-step process compliant with the TPR to assist local jurisdictions. This memorandum provides an audit of the updated TPR and establishes a strategy to update the TSP Guidelines to align with the updated rules and regulations.

TPR AUDIT

The project team completed an audit of the updated TPR to understand the changes and high-level impacts to the TSP Guidelines. The audit findings are summarized below.

Summary of TPR Changes

Each section of the TPR was reviewed and categorized as having "no change", "edits", "deleted", or as a "new section". The list below shows which sections fall under which category:

Attachment A provides further detail about each section of the updated TPR, including the title, summary of TPR changes, applicable geographies, and impacts to the TSP Guidelines.

The major changes to the updated TPR are primarily located in the new sections. These new sections apply only to specific geographic areas (primarily metropolitan areas) and provide new requirements about parking, electric vehicle charging, CFAs, equity analysis, and reporting. There are other topics discussed in the new sections that were already incorporated into the TSP Guidelines. These topics will require updates in the TSP Guidelines and primarily focus on the modal analyses, project identification and prioritization, funding, and performance standards.

Geographic Applicability

One of the main impacts of the TPR changes is that there are delineations in the rules and regulations based on the type and location of different jurisdictions. Some sections of the TPR are applicable to all geographies, some are applicable to jurisdictions in MPOs that meet specific population thresholds, and some are applicable to a more specific area within an MPO, such as CFAs.

Attachment B summarizes the geographic application of the updated TPR. This table will support the project team as updates to the TSP Guidelines move forward, especially regarding structural updates necessary to reduce confusion around where rules and regulations apply.

High-level Impacts to the TSP Guidelines

Based on the audit of both the updated TPR and the current TSP Guidelines, most sections of the TSP Guidelines will need adjustment to incorporate the updated TPR. Higher-level overview sections, such as, "What is a TSP?", are unlikely to need major changes. The sections where "shall" and "should" statements are provided, such as the Pedestrian Inventory section, will require more changes to cover the new sections of the TPR and geographic applicability impacts.

Throughout the TSP Guidelines, the project team will need to verify that mentions of MPOs, CFAs, and other areas align with the updated TPR and do not cause confusion for local jurisdictions implementing the guidelines.

A significant impact of the updated TPR is that a new generation of TSPs will be needed within metropolitan areas. For the TSP Guidelines, this means that there will need to be updates to the example TSPs, sample scopes, and other examples for MPOs, which will not be immediately available. The TPR highlights the timeline that local jurisdictions must comply with meeting the new rules. After which, a range of examples will be available for ODOT to incorporate into the TSP Guidelines.

TSP GUIDELINES UPDATE STRATEGY


There are several approaches that could be used to update the TSP Guidelines. For the three work bundles included in the scope of work, the project team recommends dividing the work by sections of the TSP Guidelines versus by sections of the TPR. This method will minimize the potential for rework and help both the project team and PMT think of the TPR in its entirety and consider implications of each TPR section on the others in the rule.

Figure 1 shows the wireframe diagram of the TSP Guidelines website structure, including the Level 1 and Level 2 overview information for non-practitioners in dark blue and light blue, and the detailed Level 3 – 6 information for practitioners in green, orange, grey, and pink boxes. In the figure, overlay boxes are used to show the proposed bundles of work. Bundle One is highlighted in red, Bundle Two in blue, and Bundle Three in purple.

Bundle One

Bundle One focuses on the home page (Level 1 content), introductory sections (Level 2 content) for TPR citations and scoping and detailed content (Levels 3-6) for the prepare phase for Step 1 – Public/Agency Engagement Plan, Step 2 – Goals/Objectives which includes evaluation criteria and performance measures which will have extensive augmenting, and part of Step 3 – Existing Conditions focused on the system inventory. This bundle allows for the project team to define the high-level impacts of the updated TPR, while digging into the new performance standards and measures requirements and the details in the inventory steps of the existing conditions section. Through the existing inventory section, the project team will test a structure for the geographic applicability changes and gather PMT input prior to implementing throughout the rest of the guidance. One potential structure would provide side-by-side guidance that covers the different geographic areas on the same page or is toggled on/off on the same page. This would allow for a similar overall website structure such as in Figure 1. Another option would branch the information early based on geographic applicability, resulting in several branches of repeating structures that have modified guidance based on context.

Bundle Two

Bundle Two will provide updated content for Steps 3 through Step 6 of the Prepare phase (Levels 3 – 6). Based off of Bundle One and comments from the PMT, this section will cover the majority of the structure changes due to geographic applicability.

Bundle Two will also include a new introductory section about geographic applicability to help users understand what guidance to use and how to find it. Discussion of partner guidance may also be included, such as how Metro's Regional Transportation Functional Plan interfaces with these TSP Guidelines.

By the end of the Bundle Two task, it is assumed that the structure will be verified by the PMT and that no major structure changes will occur in Bundle Three or beyond.

Bundle Three

Bundle Three includes content for Step 7 of the Prepare phase. As applicable and available, Bundle Three will also include updated examples³.

NEXT STEPS

After ODOT review and approval of the proposed strategy, the project team will begin creating markups for existing sections of the TSP Guidelines and for new sections needed to cover the updated TPR.

³ There are a few elements of the TSP Guidelines that may need to be updated in 2024 after the draft updated guidance is complete. These items include the different examples from completed TSPs. These examples range from scopes to individual memos to full TSPs. For now, keeping the existing examples is recommended until there are fully updated TSPs that incorporate the CFEC rulemaking and TPR updates. Examples will need to incorporate all geographic applicability use cases (i.e. county in an MPO with CFAs, small rural city, etc.)
