

Goods, Trade Services, and Public Improvement Contracts

Contracts are established through various solicitation methods including Invitation to Bid (ITB), Request for Competitive Quote (RFCQ) and Request for Proposal (RFP).

\$10,000 or Less

ODOT divisions have discretion to purchase without obtaining competitive quotes. However, competition is strongly encouraged.

\$10,001 to \$150,000 (Intermediate Solicitation)

ODOT divisions may purchase/contract within this threshold. At least 5 new requirements have been established for specific COBID certified firm categories, competitive quotes and notification to the Governor's Policy Advisor for Economic and Business Equity. Opportunities may be advertised on OregonBuys.

\$150,000 or More (Formal Solicitation)

Contracts for Goods, Trade Services, and Public Improvement projects within this amount are processed through the ODOT Procurement Office (OPO). Formal competition is required and all solicitations are advertised on OregonBuys. Certain Public Improvement projects in this category are required to be advertised in a trade newspaper of general statewide circulation. ODOT generally advertises in the Business Tribune.

Price Agreements

The Department of Administrative Services (DAS) establishes price agreements for goods and services commonly used by all state agencies. Agencies must purchase these items from the established price agreement. OPO may also establish price agreements for ODOT use only.

Highway Construction Contracts

ODOT highway and bridge construction projects are primarily solicited by Invitation to Bid (ITB). Some projects such as Design-Build, Construction Manager/General Contractor or Price+ Multi-Parameter are exempt from low bid requirements and solicited by Request for Proposal (RFP).

Construction projects are bid on a competitive basis and are advertised on ODOT's Procurement Office Construction Contracts website (<https://www.oregon.gov/ODOT/Business/Procurement/Pages/NTC.aspx>) as well as the Business Tribune and the Daily Journal of Commerce. Information regarding qualifications, subcontracting opportunities, bidding, obtaining plans, special provisions, bid results, and many other Highway Construction resources are available on our website.

Prequalification: ODOT requires prime contractors to be pre-qualified at least 10 days prior to the bid date. For more information, please visit:

The state of Oregon has a new eProcurement system. This new tool, OregonBuys, replaced the Oregon Procurement Information Network (ORPIN) on July 1, 2021.

OregonBuys is a full procure-to-pay eProcurement solution that automates procurement processes using web-based applications. This technology-enabled solution allows the state to procure goods and services at the best value.

Disadvantaged Business Enterprise (DBE) Program

The U.S. Department of Transportation is in charge of the DBE Program and decides how firms can become certified as a DBE. DBEs are able to seek contracts funded with federal transportation-related money. DBEs include small businesses that are at least 51% owned by: Minorities: Blacks, Hispanics, Native Americans, Asian-Pacific Americans and Subcontinent Asian Americans; Women; Other individuals on a case-by-case basis.

- Oregon Highway Division/ODOT's first slogan in 1913: "Get Oregon Out of the Mud".
- ODOT Highway Division maintains 8,041.78 miles of roads, totaling 19,113.12 lane miles of roads and highways.
- ODOT owns and maintains 2,700 bridges with an average age of 42 years.
- In 2009, ODOT Rail inspectors examined: 10,097 locomotives and rail cars, 3,063 miles of track and 1,862 turnouts and 1,634 railroad/highway crossings.
- Each year Oregon Driver and Motor Vehicle Services (DMV) registers nearly 2 million vehicles and monitors the driving privileges of about 2.7 million drivers.
