

Utility Permit Cultural Resource Review Notification

Note: This form may be used by a utility company to notify the Tribe(s), identified by the Legislative Commission on Indian Services (LCIS), www.oregonlegislature.gov/cis, of the potential installation of a utility line including moving or repositioning existing lines or poles ("install a utility line") on state highway right of way. The information collected may be used to complete the forms needed to obtain a permit to install a utility line on state highway right of way and is not submitted to the Oregon Department of Transportation.
