ALL LEVELS	Proof of a current American Heart Association Basic Life Support (BLS) Provider or equivalent CPR course completion document (this course must include a practical skills evaluation).

EMR	Expired <12 months	Proof of current NREMT certification or , complete the CE (Reference Appendix 1)
EMR	Expired >12 months	Must retake an EMR course and pass the cognitive and psychomotor examinations.

EXPIRED LESS THAN 3 MONTHS	
EMT	Proof of current NREMT certification or , complete the CE requirements specified in Appendix 1
ADVANCED	Proof of current NREMT certification or , complete the CE requirements specified in Appendix 1
INTERMEDIATE	Complete the CE requirements specified in Appendix 1
PARAMEDIC	Proof of current NREMT certification or , complete the CE requirements specified in Appendix 1

EXPIRED MORE THAN 3 MONTHS, BUT LESS THAN 24 MONTHS	
EMT	OPTION 1: Proof of current NREMT certification or , OPTION 2: Complete EMT refresher training program accredited by the Commission on Accreditation for Prehospital Continuing Education (CAPCE) or complete the CE requirements specified in Appendix 1, AND successfully pass the National Registry's EMT cognitive examination.
ADVANCED	OPTION 1: Proof of current NREMT certification or , OPTION 2: Complete an AEMT refresher training program accredited by the Commission on Accreditation for Prehospital Continuing Education (CAPCE) or complete the CE requirements specified in Appendix 1, AND proof of BTLS or PHTLS, AND successfully complete National Registry's AEMT cognitive examination.
INTERMEDIATE	All requirements listed in OPTION 2 for AEMTs AND successfully complete a simulated cardiac arrest management skill evaluated by the EMS Medical Director or his or her designee, or person approved by the Authority.
PARAMEDIC	OPTION 1: Proof of current NREMT certification or , OPTION 2: Complete a paramedic refresher training program accredited by the Commission on Accreditation for Prehospital Continuing Education (CAPCE) or complete the CE requirements specified in Appendix 1, AND proof of ACLS, AND BTLS or PHTLS, AND APLS or PALS or PEPP or NALS, AND successfully complete the National Registry's paramedic cognitive examination.

- Licenses expired greater than 24 months at the EMT, AEMT and paramedic levels, must complete a "New License" application and show proof of current National Registry certification.
- Licenses expired for greater than 24 months at the EMT-Intermediate level may reinstate at the Advanced EMT level if previously certified at the AEMT level by the National Registry. Proof of current National Registry certification at the AEMT level is required.
- EMT-Intermediates who have been expired for greater than 24 months, who have never held an AEMT certification with the National Registry must reinstate at the EMT level. Proof of current National Registry certification at the EMT level is required.
