### Letters of Intent

**Willamette Valley Hospice** proposes to develop a 12-bed Freestanding Inpatient Hospice Facility to be located in West Salem on its campus. On January 12, 2018, this project was ruled to be subject to full review under Certificate of Need law. This project may be eligible to proceed under the abbreviated review process.

### Applications under Review

**Lifeways, Inc.** proposes to construct and operate a 16-bed freestanding psychiatric hospital to be located in Hermiston, Oregon. The proposed facility would serve adolescents age 18 years of age or older, and adults, both voluntary and involuntary. On August 24, 2017, the application was ruled to be complete and review began on August 25, 2017. The applicant has opted to provide additional information to the Division. A proposed decision will be issued no later than March 15, 2018.
