Satellite Committee Update

- Next RSAC meeting, the committee will present its recommendations
- Recommendations include:
 - Definition of "primary" and "satellite" sites
 - Opening and running satellite sites
 - Transportation
 - Differences between roles within primary, satellite and remote learning
 - Interscholastic activities
 - Ensure communication and transparency with 9 Federally recognized Tribes
 - Sharing of health protected information / IGAs / MOUs

RSAC Membership Update

Background: One of the current RSAC members was hired to be ODE's new Recovery School Specialist and will no longer be serving on the committee, but will be facilitating it. According to the <u>RSAC Charter</u>, a committee needs to review and approve new members to complete vacated seats.

Update: We have reopened the applications and have sent an email out to our RSAC listserv, rural area administrators and others.

- March 18, 2024 closing date for new applicants.
- March 20,2024 review applicants to fill one position: 1) Administrator of a school district or an ESD in a rural district or Tribe.
- March 22, 2024 confirm candidate and announce to RSAC committee.
