FINDINGS OF FACT

(1) On February 1, 2018, Parent filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of J.V. (Student). The Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Administrative Law Judge (ALJ) Jill Marie Messecar to preside over the hearing in this matter.

(2) On February 26, 2018, Parent notified the Department of Education that the parties had settled the matter and wished to withdraw the hearing request with prejudice. On January 27, 2018, the Department of Education notified the OAH via email that the Parent had withdrawn the due process complaint.

ORDER

The February 1, 2018, request for a due process hearing has been withdrawn and the case is dismissed.
