FINDINGS OF FACT

(1) On March 5, 2018, Parent filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of L.C. (Student). The Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Administrative Law Judge (ALJ) Jill Marie Messecar to preside over the hearing in this matter.

(2) On April 12, 2018, Parent notified ALJ Messecar and the District during a telephone pre-hearing conference that the District had resolved the issue and that she wanted to withdraw the due process complaint without prejudice.

ORDER

The March 5, 2018, request for a due process hearing has been withdrawn and the case is dismissed without prejudice.
