FINDINGS OF FACT

(1) On June 14, 2018, Parent filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of Student.

(2) On June 14, 2018, the Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Senior Administrative Law Judge (ALJ) Joe L. Allen to preside over the hearing in this matter.

(3) On July 2, 2018, Parent notified the OAH that he wished to withdraw the hearing request.
