**FINDINGS OF FACT**

(1) On January 7, 2020, Parents filed a request for a due process hearing. On that same date, the Oregon Department of Education referred the request to the Office of Administrative Hearings.

(2) Administrative Law Judge D. McGorin held a pre-hearing conference on February 7, 2020. Christine Furrer represented Parents. Robin Day represented the Beaverton School District 48J. The parties waived the 45-day rule so they could mediate. The matter settled at mediation. On July 31, 2020, Ms. Furrer requested that the case be dismissed with prejudice.

**ORDER**

Parents' request for a due process hearing has been withdrawn and the case is dismissed with prejudice.
