**FINDINGS OF FACT**

(1) On March 25, 2022, Parents filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of Student.

(2) On March 29, 2022, the Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Administrative Law Judge (ALJ) Alison Greene Webster to preside over the hearing in this matter.

(3) On August 3, 2022, counsel for Parents filed a Motion to Dismiss with Prejudice, notifying the ALJ that Parents wished to withdraw the hearing request based on resolution of all issues in the due process complaint.

**ORDER**

The Parents' request for a due process hearing has been withdrawn and the case is dismissed with prejudice.
