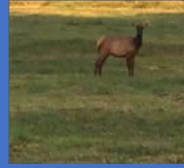


## SB 13 Tribal History/Shared History

We hope this monthly update finds you and your families in good health. We extend our appreciation for all of your patience, understanding and efforts in assisting students, family members and your communities during this time.

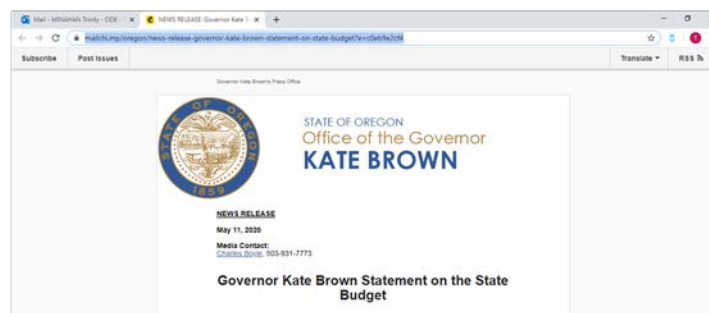

We also wanted to make you aware that ODE is preparing for the budgetary impacts of COVID-19 on Oregon. All agencies have received instructions for providing prioritized reductions to reduce biennial general fund appropriation allotments by just over 8.5%. 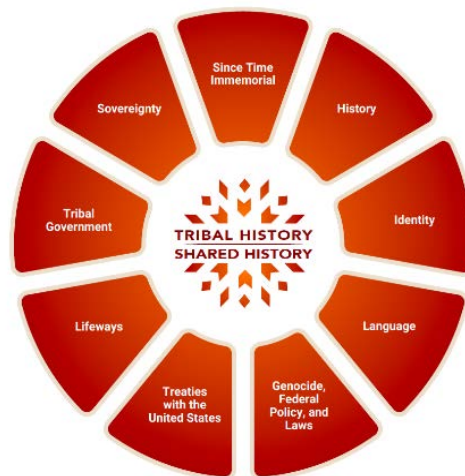

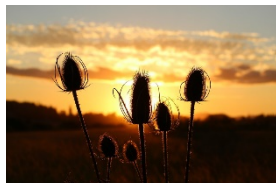
