## Special Duty Summary:

Selected will be required to perform the following tasks: Inspect, repack, assemble, repair, test, evaluate and operate various Special Tactics airborne delivery systems--to include ram-air, static-line parachute systems, and precision aerial delivery systems. Inspect, maintain, and fit non-standard life-sustaining equipment to include high altitude parachutist oxygen systems, night vision devices, and thermal imaging devices. Rig inflatable amphibious boats and other cargo for airdrops. Instruct and demonstrate advanced equipment concepts for special mission equipment used in support of Special Tactics missions. Candidate must be able to comprehend manufactures' manuals for non-standard equipment when AF Technical Orders are not available. Volunteer is required to be a highly motivated and well-rounded individual who is capable of working unsupervised, handling multiple tasks with time constraints often encountered under adverse timecritical conditions. Prior static line and military freefall (MFF) parachutist experience is highly desired. Ideal candidate will be a graduate of the following courses: J3AZR1P051 0M1A Static Line Parachute Systems or MC-6 Static Line Parachute System USAQMCS Ft. Lee, VA, J3AZR1P051 0R1A Ram Air Parachute Systems or Ram Air Parachute Systems USAQMCS Ft. Lee, VA or Natick approved RA-1 NET, and L9AZA2T251 00AA Air Drop Specialists Course [Riggers] USAQMCS Ft. Lee, VA. The 125 STS AFES may waive requisite qualifications if applicate does not possess, in which case applicant must be willing to complete training within 12 months of accession. Applicant must be world-wide deployable. Applicant must be capable of lifting 50 lbs unassisted.
