### HOMEBUILT BOAT BUILDER CERTIFICATE

HOMEBUILT boats are boats constructed by an individual that is not registered with the United States Coast Guard as a builder/manufacturer. An inspection may be requested after receipt of an application.

**Instructions:**

1. Complete all sections of this form when construction of the watercraft is complete.
2. Submit 3 pictures of the boat: a side view, rear view and one with a tape measure across the centerline for length verification.
3. *Submit with an application for title and registration with appropriate payment.*

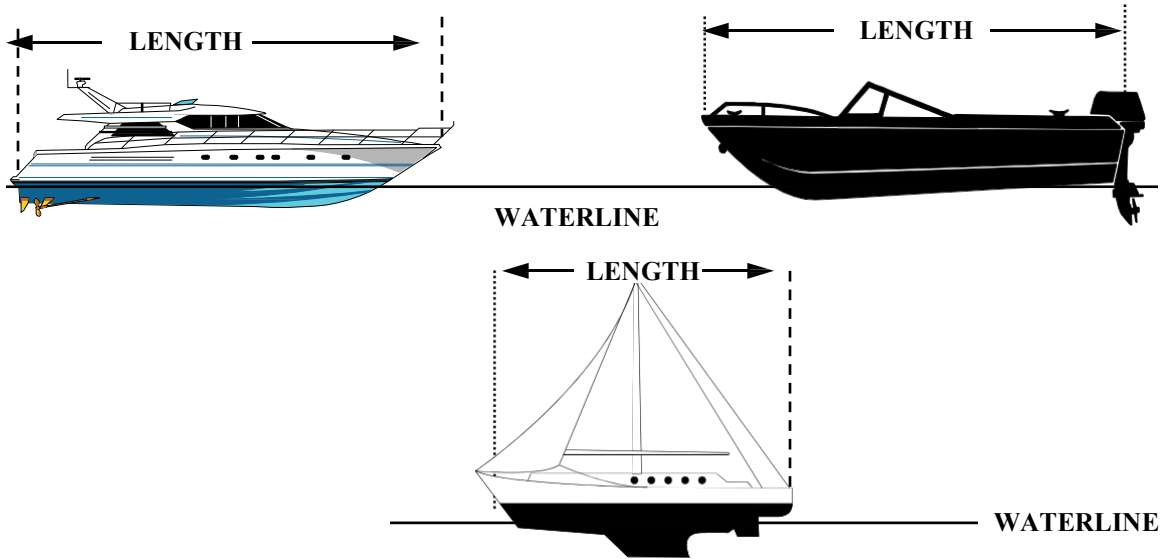

## HOW TO MEASURE A BOAT

The length is measured from end to end excluding sheer. This is a straight line measurement of the overall length from the foremost part of the boat to the aftermost part of the boat, measured parallel to the centerline. Bow sprits, bumpkins, rudders, outboard motor brackets, and similar fittings or attachments are not included in the measurement. Length shall be stated in feet and inches.



### Definitions:

“Boat” means every description of watercraft, including a seaplane on the water and not in flight, used or capable of being used as a means of transportation on the water, but does not include boathouses, floating homes, air mattresses, beach and water toys or single inner tubes. ORS 830.005

(2) “Motorboat” means any boat propelled in whole or in part by machinery, including boats temporarily equipped with detachable motors. ORS 830.005 (6)

“Floating home” means a moored structure that is secured to a pier or pilings and is used primarily as a domicile and not as a boat. ORS 830.700 (4)
