FINAL ORDER

The Board of Clinical Social Workers (Board) is the state agency responsible for licensing and disciplining clinical social workers, and for regulating the practice of clinical social work in the State of Oregon. Janice Elliott, LCSW (Licensee) is licensed by the Board to practice as a clinical social worker in Oregon.

1.

The Board issued a Stipulated Final Order on June 17, 1999 imposing a sanction of reprimand against Licensee.

2.

The June 17, 1999 order prohibited Licensee from supervising candidates for licensure for mental health professions. The prohibition was effective immediately.

ORDER

IT IS HEREBY ORDERED that the prohibition for supervision of candidates for mental health professions be vacated. Janice Elliott, LCSW may supervise candidates for health professions. This order is effective immediately.

IMPOSING DISCIPLINE

7 The Board of Clinical Social Workers (Board) is the state agency responsible for
8 licensing, regulating and disciplining psychologists in the State of Oregon. Janice Elliott, LCSW
9 (Ms. Elliott), was licensed as a social worker by the Board, and has practiced in Medford,
10 Oregon.

11 1.

12 On December 2, 1998, Licensee was served with a Notice of Reprimand and Restriction
13 of Practice for permitting a dual relationship between a supervisee and a patient.

14 1.1 On April 27, 1999, Licensee submitted to the Board a written offer to settle this
15 matter.

16 1.2 The Board and Licensee agree that the December 2, 1998 Notice of Reprimand
17 and Restriction of Practice may be informally resolved as set out in this document.

18 2.

19 The Board and Licensee agree to the following facts:

20 2.1 Licensee has been a clinical social worker since 1988. Previously, Licensee was a
21 practicing psychotherapist and a faculty member in the Psychology Department of Southern
22 Oregon University. With these credentials, Licensee has been supervising and training therapists
23 for approximately 18 years.

24 2.2 On June 15, 1998, the Board received a complaint that Licensee was engaged in
25 unprofessional conduct as a clinical social worker in the supervision of ^{P.R.} [REDACTED].
