STIPULATED
AGREEMENT

Pursuant to ORS 675.540, the above-entitled matter came
before the State Board of Clinical Social Workers (Board) on the
complaint of R. B. B.

Pursuant to ORS 183.415(5) and OAR 877-40-045, in order to
informally dispose of and settle this matter, John Louden
(Louden), and the Board by and through its Chair, Carol Ormiston,
make the following statements:

1.

Louden admits and stipulates that he has been advised of his
right to request a hearing in this matter pursuant to ORS
183.415(2)(a) and to be represented at a hearing pursuant to ORS
183.415(3).

2.

Louden waives his right to request such a hearing in this
matter.

3.

Under ORS 675.560(2) Loudens license (license number 1447)
as an LCSW expires on December 31, 1992;

4.

The Board and Loudens stipulate and agree that in lieu of

1 hearing on the revocation of Louden's license to practice as a
2 clinical social worker:

- 3 (a) That Louden agrees not to practice therapy of any
4 sort from the date of entry of this order until
5 January 1, 1993;
- 6 (b) That in lieu of a hearing on the incidence of
7 sexual acts and contacts with [REDACTED], Louden
8 agrees to allow his license to expire on December
9 31, 1992;
- 10 (c) That on the date of entry into this agreement,
11 Louden hereby requests that license number 1447 not
12 be renewed and further requests, as of December 31,
13 1992, that his license be treated as lapsed
14 notwithstanding ORS 675.571(4);
- 15 (d) That Louden will not seek renewal of license number
16 1447;
- 17 (e) That, on or before midnight, December 31, 1992,
18 Louden will surrender his license to practice as an
19 LCSW to the Board office at 895 Summer Street NE,
20 Salem, Oregon 97310;
- 21 (f) That Louden will not seek licensure with the Board
22 before July 1, 1993;
- 23 (g) The Board will publicize this Stipulated Agreement
24 by the announcement in the NASW Newsletter, the
25 Board's own newsletter and, if it so chooses, in
26 the Oregonian;
- 27 (h) That the complaint made by [REDACTED] ^{B.} against Louden
28 may be considered by the Board as part of its
29 determination of Louden's competency to be
30 licensed, if after July 1, 1993 Louden seeks
31 licensure with the Board;
- 32 (i) That, with regard to [REDACTED] ^{B.} complaint, this
33 agreement is not an admission of gross negligence
34 on the part of Louden.

36 If the Board finds, after a contested case hearing, that
Louden has materially violated any of the terms of this

1 Stipulation, that violation shall constitute grounds for
2 revocation and Louden's license may be immediately revoked.
