Pursuant to ORS 675.540, the above-entitled matter came before the State Board of Clinical Social Workers (Board) on the complaint of JNB (Complainant).

Pursuant to ORS 183.415(5) and OAR 877-40-045, in order to informally dispose of and settle this matter, Kenneth E. Pierce (Licensee), and the Board, by and through its Administrator, Elizabeth Buys, make the following statements:

1.

Licensee admits and stipulates that he has been advised of his right to request a hearing in this matter pursuant to ORS 183.415(2)(a) and to be represented at a hearing pursuant to ORS 183.415(3).

Licensee waives his right to request such a hearing in this matter.

Under ORS 675.560(2) Licensee's license, #1849, as an LCSW expires on December 21, 1994.

2 The Board and Licensee stipulate and agree that in lieu of  
3 hearing on the revocation of Licensee's license to practice as a  
4 clinical social worker:

- 5 (a) That Licensee agrees not to practice therapy of any sort  
6 from the date of entry of this order until April 1, 1995;
- 7 (b) That in lieu of a hearing on the incidence of sexual  
8 acts and contacts with Complainant, Licensee agrees to  
9 allow his license to expire on April 1, 1995;
- 10 (c) That on the date of entry into this agreement, Licensee  
11 hereby requests that license number 1849 not be renewed  
12 and further requests, as of March 31, 1995, that his  
13 license be treated as lapsed notwithstanding  
14 ORS 675.571(4);
- 15 (d) That Licensee will not seek renewal of license number  
16 1849;
- 17 (e) That, on or before midnight, March 22, 1995, Licensee  
18 will surrender his license to practice as an LCSW to the  
19 Board office at 3218 Pringle Road SE, Suite 140, Salem,  
20 Oregon 97302-6310;
- 21 (f) The Board will publicize this Stipulated Agreement by  
22 the announcement in the NASW Newsletter, the Board's own  
23 newsletter and, if it so chooses, a newspaper of the  
24 Board's choice;
- 25 (g) That the complaint made by Complainant against Licensee  
26 may be considered by the Board as part of its  
determination of Licensee's competency to be licensed,  
if after April 1, 1995, Licensee seeks licensure with  
the Board;
