The Board of Licensed Social Workers (hereafter referred to as “Board”) is the state agency responsible for licensing, regulating and disciplining regulated social workers in the State of Oregon, including but not limited to Licensed Clinical Social Workers, pursuant to ORS 675.510 to 675.600 and OAR Chapter 877.

2.

At all times material herein, Respondent Alan King, LCSW (hereafter referred to as “Respondent”), was licensed with the Board as a Licensed Clinical Social Worker (LCSW), License No. L004409, and subject to the full jurisdiction of the Board. Respondent has been a licensee or certificate holder of the Board since being granted his Clinical Social Worker Associate Certificate on December 3rd, 2003. Respondent was granted his Clinical Social Work license on March 4th, 2009.

As a licensee, Respondent had a duty to ensure he did not participate in, condone or be associated with dishonesty, fraud, deceit or misrepresentation to the Board, pursuant to OAR 877-030-0040(1)(b), and other applicable authority.

3.

On November 30th, 2009, the Board received a written complaint alleging the Respondent was the subject of an employment related investigation stemming from an alleged incident on September 25th, 2009.

On February 9th, 2010, the Board received the Respondent's 2010 Licensed Clinical Social Worker Renewal Application for the period of April 2010 – March 2011, accordingly. As part of that application and renewal process, Respondent was asked and answered a series of questions and certified that said statements were true and correct as follows:

Have you been reprimanded or suspended from practice by any agency, employer, board tribunal, etc? *Respondent marked the box "No."*

Have you been the subject of a complaint to a self-regulated professional organization, licensing board or agency? *Respondent marked the box "No."*

Have you been found to have violated any professional organizational rules, by-laws, etc? *Respondent marked the box "No."*

CERTIFICATION: By my signature below, I certify the following:

I have answered the mandatory questions and certify that all statements are true and correct to the best of my knowledge. I am engaged in meeting the Continuing Education requirements as defined in OAR 877-025-0000. The information I have reported is complete, accurate, and the CE activities are clinical in nature." Respondent executed the renewal form by his signature and date of 02-04-2010.

Respondent admits to having falsely answered the above questions on his renewal application by knowingly not disclosing and explaining the above referenced employment matter.

6.

Based on the foregoing, the Board finds and Respondent admits that Respondent engaged in dishonesty, fraud, deceit or misrepresentation when Respondent knowingly answered falsely the above questions on a Board application. Respondent's conduct violates OAR 877-030-0040(1)(b).

7.

Respondent and the Board desire to resolve this matter by entry of this Stipulated Agreement and Final Order, pursuant to ORS 183.417(3).

Under the authority of ORS 675.540(1)(f), (2)(c) and ORS 675.595(9), Respondent is **ASSESSED** a civil penalty in the amount of \$500.00 (five hundred dollars) for the above violations. This civil penalty must be paid in full within thirty (30) days of issuance of this Order.

9.

Respondent understands, acknowledges and agrees to the following:

9.1 This Stipulated Agreement and Final Order (Hereafter referred to as ORDER) will be submitted to the Board for approval and is subject to and conditioned upon the approval by the full Board.

9.2 This ORDER, once issued, is a Final Order.

9.3 This ORDER is a public document and a matter of public discipline. This document must be disclosed, published and reported in accordance with ORS 676.175(5)(a)(D), OAR 877-040-0050, and Oregon Public Records Law.

9.4 This ORDER in no way limits or prevents further remedies, sanctions, or actions which may be available to the Board under law for conduct or actions of Respondent not covered by this ORDER, or against a party not covered by this ORDER, or for Respondent's failure to comply with the terms of this ORDER.

9.5 Respondent has been fully advised of Respondent's rights to notice and a contested case hearing under the Oregon Administrative Procedures Act (ORS Chapter 183), and Civil Penalty Procedures of ORS 183.745 and fully waives any and all such rights and any rights to appeal or otherwise challenge this ORDER; *and*

9.6 Respondent has fully read this ORDER and understands it completely. Respondent voluntarily, without any force or duress, consents to issuance and entry of this ORDER as written. Respondent states that no promises or representation have been made to induce Respondent to sign this ORDER. Respondent has consulted with an attorney

1 regarding this ORDER and has been fully advised in regards thereto, *or* waives any and
2 all rights to consult with an attorney prior to issuance and entry of this ORDER.
