B. Internal Review

The Rules and Policy Subcommittee has recommended that revised standards containing related training revisions be required to meet all related training curriculum requirements set forth in OAR 839-011-0084(f).

C. Reciprocal Standards – Discussion

There are issues involving the standards for three Washington programs that are dual registered in Oregon under the reciprocal agreement. Differences in state license requirements have complicated the use of reciprocal standards and information in the Oregon standards is outdated. The division is working with Washington Labor & Industries Apprenticeship and the affected programs to modify the Oregon standards format for reciprocally registered programs. Proposed standards will be submitted for subcommittee review in December 2009. This is an administrative change that will not impact the reciprocal agreement or the programs' primary Washington registration.

The committee requested extension pending determination of retirement date for current journey worker, noting they would likely start an apprentice 12 - 18 months prior to the retirement date. The division expressed concern with this timeline, since the standards require 6000 OJT hours (generally 3 years) and it is unclear how the apprentice would receive supervision for the remaining 18 - 24 months after the journey worker retired.

The committee chair (Keith Putman) informed Ms. Farmer that an additional journey worker was available to provide apprentice supervision within ratio requirements. Based upon this information, Mr. Putman was told he need not attend the meeting.

Mr. Ferguson voiced concern about supervision at the training agent level and requested more specific information regarding available journey workers.

Mr. Rogers expressed his concerns regarding the program's operation, noting similar problems with the committee over the years. Mr. Simms concurred, acknowledging that tribal programs must deal with several different bureaucracies, making administration difficult. He suggested deferring the item to December 2009, requiring committee representation at that time to address the issues.

The motion was retracted by the maker who then presented a new motion.

This is a new program for residents of the Oregon Youth Authority (OYA), administered by OYA. The proposed standards are consistent with the existing LBME trainee program (MA 1144) with the exception

of ratio. The division recommended approval of the standards since the proposed ratio is consistent with other Council-approved inmate programs and more restrictive than that of the existing program.

Program representatives stated that one of OYA's key goals is remediation of youth and creation of opportunities for change. Approval of the program would allow utilization of existing resources to give youth a head start when released back into the community.

Subcommittee discussion centered on the following areas:

Ratio and supervision: Concerns regarding the proposed ratio and possibility of unsupervised work were expressed. Program representatives responded that apprentices would be directly supervised throughout the program. The youth experience program requires a minimum of two youth to each supervisor, within line-of-sight of the supervisor at all times.

Ratio exceptions are permitted by statute for Department of Corrections (DOC) institutions and there was discussion about the correlation between the OYA and the DOC. The division will investigate whether the exception applies to the OYA.

Entry requirements: Requirements are as high as DOC requirements. In addition to the general requirements outlined in the standards, the inmate's Cottage Supervisor's authorization is required to participate. To gain authorization, they must have a meticulous behavior record and meet very high expectations.

Affirmative action and diversity: The program anticipates starting with approximately 6 apprentices, which would require Council approval of an affirmative action plan. The importance of including minorities was noted. The Oak Creek facility for women is very interested in starting the program.

Other approval options: The LBME license does not require completion of an apprenticeship. Programs can be directly approved by the Electrical and Elevator Board (EEB), but these requests are typically referred back to the division.

Subcommittee members noted that the program more closely resembles a trainee program with respect to ratio, related training received, and the inability to make independent decisions. Program representatives felt that the proposed program would be as qualified, if not more so, than other apprenticeship programs, adding that apprentices would be allowed make independent decisions, while being under constant supervision.

This is a new standard for inmate training administered by an outside committee. DOC submitted a letter of support.

The submission was incomplete and the division recommended referral back to the committee unless the outstanding items could be resolved prior to the September 2009 Council meeting. Program representatives felt the issues noted could be resolved in time:

Trainee and training agent cost information

Related training curriculum certification, clarification of delivery method

Ratio, clarification of supervision within correctional facility

Policies and procedure modification to incorporate correctional issues

Subcommittee members expressed their concerns regarding the inflated ratio, unsupervised work by trainees, and entry criteria for the program. Supervision requirements of OAR 918-282-0260 were reviewed.

Mr. Parker stated that the proposed program meets DOC criteria for the Coffee Creek women's facility. He confirmed that trainees would be directly supervised by general journeyman electricians for the first 80 OJT hours, and under some type of supervision at all times. Proposed entry requirements are more stringent than for other DOC programs because the work is performed in a plant outside of the secure perimeter of the institution.

The committee proposes to incorporate on-line and in-house courses into its related training. These courses do not contain a hands-on component, which is available in the community college classes currently being utilized. The standards were forwarded with no recommendation since it is unclear how the proposed courses would impact apprentices who are currently attending community college classes, and a structured plan for providing all required training had not been submitted. Mr. Simms described the difficulty for staff in determining whether a third-party vendor would meet the established course outlines and expected competencies as outlined in the standards.

Mr. Campos stated that the committee's first choice for related training continues to be community college classes. The options are being added only for apprentices who are unable to take those courses and they would be required to submit justifiable reasons for not utilizing the current related training system. These options would provide work-life effectiveness and cost options to the company to meet business demands.

Subcommittee members expressed concerns regarding training validation and on-line exams. They strongly encouraged using on-line college courses instead of third-party providers and suggested the committee work with the community college to develop on-line curriculum that could be used statewide. The committee could then submit the standards with a credible and validated on-line option.

Mr. Campos acknowledged that the training would need to be accredited prior to being approved by the committee and meet or exceed that of the community college courses. He added that in-house training would only be utilized for license renewal requirements. He believes that the community college would need to initiate efforts to create on-line curriculum, but the committee would collaborate with them.

In the interim, if the committee would agree to provide a coursework outline and documentation of delivery methods for staff review, the division could determine whether the alternate method is equivalent to the college courses, is validated, and meets the educational requirements in the standards.

Mr. Ferguson suggested that the Council establish related instruction criteria for new technology as it becomes available, including curriculum validation options. Dr. Hill noted that regional accreditation would provide the best assurance of quality training, since there are no national standards for national accreditation.

The division has been working with several committees to clarify the issue and draft language that would meet all requirements. Subcommittee members were provided with copies of the finalized language.

MA 3001 – Mr. Baker confirmed that the committee had decided to incorporate the final language into their standards to prevent future compliance issues on federal projects.

MA 4009 – Finalized language has not yet been approved by the committee. The division recommended approval contingent upon adoption.

Apprenticeship Representative Petersen reported that all four standards were found in compliance. The committee has established subcommittees for each institution and has done a remarkable job of ensuring that recordkeeping is precise.

License exam results for apprentices in these programs greatly surpass those of the general population. In 2008, only 57% of all exam applicants passed the Manufacturing Plant Electrician (MPE) exam on their first attempt, compared to a 100% pass rate for the program. One graduate of the program has been released and is employed as an MPE. Four other individuals have obtained their license, have moved to the minimum security facility, and are currently working in the facility in their trade. Mr. Petersen emphasized that the committee and apprentices take the program and ongoing ratio concerns very seriously and encouraged council members to visit the facility and see the program for themselves.

An affirmative action review was not conducted since each of the participating institutions acts as a separate training agent and only two of the standards have five or more apprentices. Revised standards to reflect the industrial selection model will be submitted for Council approval in December 2009. Affirmative action reviews will be conducted during subsequent reviews for each facility with 5 or more apprentices in an occupation.

The combined minority participation rate for all standards is 29%, almost double the 14% minority population within the institutions. The female participation rate is lower due to the physical location of the plant outside the secured area. It is anticipated that female participation will pick up in the painter and LBME program (if approved), as the work for these programs will be performed within the confines of the institutions.
