Law Changes Effective January 1, 2010

Beginning January 1, 2010 contractors working on residential structures will have several law changes they need to be aware of.

Residential construction contracts

The 2009 Legislative Assembly made some minor changes to the laws enacted in 2008 that required written contracts for residential construction or improvements contain certain information.

The information below is the complete requirement including what became effective in 2008 and what becomes effective January 1, 2010.

The following information must be included in your contract with a residential property owner:

- A statement that the contractor is licensed by the CCB and the contractor's name, CCB license number, address and phone number on the CCB records. (2008)
- A list of the residential consumer notices required. (OAR 812-012-0130)* (2010)
- An explanation of the property owners' rights and responsibilities under the contract including their ability to file a complaint with the CCB. (2008)
- The existence of arbitration or mediation so it is conspicuous. (2008)
- Customer name, address and the address where the work is to be performed. (2008)
- A description of the work to be performed. (2008)
- Contract price and payment terms. (2008)

**The 2008 law required a summary of the residential notices.*

Additionally, if contractors were constructing a new residential structure, they were required to include a maintenance schedule at the time of the written contract (2008). This law was also modified. (See Maintenance Schedules on page 2.)

Information Notice to Owner About Construction Liens

Beginning January 1, 2010, the law governing when contractors must provide consumers the *Information Notice to Owner about Construction Liens* will change.

As of January 1, 2010 contractors will provide the *Information Notice to Owner about Construction Liens* when the contract to construct or improve residential property is more than \$2,000*.

**Prior to this law becoming effective, contractors provided the notice to residential customers the when the contract price of the work was more than \$1,000.*

This change streamlines the law and makes it easier for contractors by requiring a written contract and all the notices at the same time. If the contract price is more than \$2,000, contractors must provide:

- A written contract**
- Information Notice to Owner about Construction Liens
- Consumer Protection Notice**
- Notice of Procedure**

***Laws governing these requirements were not changed.*

It is important to remember that if the contract starts out less than \$2,000 but goes over that amount, you are obligated to provide all the above.

Maintenance Schedules

During the 2007 Legislative Assembly, lawmakers passed legislation requiring contractors that construct new residential structures provide the property owner or original purchaser:

- A written offer of a warranty
- A recommended maintenance schedule (Was required to be included as part of the written contract.)

Effective January 1, 2010, the maintenance schedule is not required to be included as part of the contract but must be given at the time the offer of the written warranty is given.

Commercial continuing education certification begins with July 2010 renewals

Commercial contractors, when renewing their license beginning July 1, 2010, must complete the amount continuing education required for their specific commercial endorsement. The continuing education must be completed by one or more of the contractor's key employees. Contractors will certify compliance on the renewal application.

To determine the amount of continuing education required, contractors that are a Commercial General Contractor Level 1 (CGC1) or Commercial Specialty Contractor Level 1 (CSC1) will use the number of key employees the contractor had on the date of the previous license issue or reissue.

Example: The contractor's license (CGC1 or CSC1) will renew on July 1, 2010. Two years earlier, on July 1, 2008 (the date of the previous issue or reissue) the contractor had 3 key employees. Using the chart below, the contractor can determine 48 CE hours are needed for renewal.

*Over the 2-year licensing period.

A Level 2 in either endorsement is required to have completed 32 hours no matter how many key employees were with the business.

A key employee is defined as an owner or employee who is one of the following:

- Corporate officer
- Manager
- Superintendent
- Foreperson
- Lead person
- Any other person who exercises management or supervisory authority over the construction activities of the business

Locksmith Certification Program

During the 2009 Legislative Assembly, law makers passed House Bill (HB) 3127, which requires the Construction Contractors Board (CCB) to create a program that will begin certifying individuals as locksmiths.

The CCB has established a Locksmith Advisory Committee (LSAC) to develop practices, policies and rules for the program. To date, LSAC has had two meetings (November and December) and discussed issues such as licensing, testing requirements, criminal convictions that should bar certification, and standards of practice.

The committee is co-chaired by two CCB board members, and the six committee members are comprised of professional locksmiths and a member of the community. The LSAC will continue to meet once or twice each month with the goal of having rule adoption completed, and a program in place by the middle of January 2010.

Beginning July 1, 2010, an individual or business may not advertise, use the word "locksmith" to describe its services, or perform locksmith services (certain exemptions apply) unless certified by CCB.

Lead-Based Paint Program

Starting in April 2010, federal law requires that all contractors that renovate "target housing" or "child-occupied facilities" must be licensed for that work. Generally speaking, "target housing" is housing built before 1978. "Child-occupied facilities" are places frequented by children ages six and under. "Renovation" includes the following.

- Removing, modifying or repairing painted surfaces.
- Removing building components like walls, plumbing or windows.
- Window replacement.
- Weatherization projects.
- Work that disturbs painted surfaces.

The federal law is intended to protect individuals from possible lead exposure. The federal law does not require that there be proof that buildings contain lead-based paint (LBP). Instead, it assumes *possible* exposure from renovating certain buildings.

To satisfy the federal law, Oregon adopted a state law (HB 2134 (2009)) creating a "certified LBP renovation contractor" license.

HB 2134 directs the DHS to adopt rules establishing standards for LBP renovation, accredit training providers and certify individuals and firms to perform LBP renovation. The state law directs the CCB to establish a system to license contractors to perform LBP renovation. Current laws governing lead-based paint activities remain unchanged.

Civil Penalties Issued July 01, 2009 - September 30, 2009

The Oregon Construction Contractors Board (CCB) recently announced final orders assessing civil penalties issued to Oregon contractors for violation of the Construction Contractors Law (ORS 701). Oregon law requires all construction contractors to be licensed with the CCB before they advertise, bid on, or perform construction, remodeling, or repair work.

Contractors receiving penalties include the following:
