FORM 3/LOCAL GOVERNMENT USE OF PROCEEDS-ANNUAL REPORT

ORS Chapter 475A requires that "Political subdivisions of the state who receive forfeiture proceeds under this section shall submit a report to the Asset Forfeiture Oversight Advisory committee for any year in which those proceeds are received... The forms shall require the political subdivision to report on how those proceeds have or will be used." Local government personnel should complete Form 3 annually, due on December 15 for the last ending fiscal year.
