SMALL PURCHASE ORDER TRANSACTION SYSTEM (SPOTS)
FIRSTVIEW LICENSE AGREEMENT**

The _____ (Agency) wishes to participate in the Firstview Software License Agreement ("Agreement") established by and between U.S. Bancorp Card Services, Inc. ("USBCS") and the Department of Administrative Services (DAS), the Program Administrator. By entering into this Agreement, Agency agrees to abide by the terms of this Agreement and those described in the Master Firstview License Agreement entered into by the Program Administrator and USBCS. A copy of the complete Firstview License Agreement is available from DAS.

Subject to the approval of the SFMS Section, DAS hereby grants to Agency permission to use the current version of the software known as Firstview in accordance with the manuals, instructions, policies and guidelines provided by USBCS. (The software and the documentation collectively are the "Software"). The license is terminable, non-transferable, and is limited to the right to use the Software during the term of this Agreement and our contract with the bank.

Agency acknowledges that the title and ownership of the Software shall remain with USBCS. Except to make one copy of the Software for archival purposes, the Agency shall not allow the Software to be copied, reproduced, disclosed, modified, revised, or manufactured in any way without the prior written consent of USBCS. If the Agency elects to download the Software to the agency's Intranet, the Agency agrees to always include the proper copyright notice at the beginning of the Software as described in the Master Firstview License Agreement. Agency is prohibited from uploading the Software to the Internet.

Agency agrees that upon termination of this Agreement, or the expiration or termination of the Small Purchase Order Transaction System (SPOTS) program, to immediately return all originals and copies of all confidential and/or proprietary materials of USBCS then in Agency's possession, and to delete the Software from all of its computer systems and/or storage devices.
