**NOTES:** Columns:

- (1) *Citizen complaints allege that a driving activity could either cause a crash or be inappropriate state vehicle use.*
- (3) *Total incidents is the sum of vehicle collisions plus police citations. Vehicle collisions consist of those that occur in state vehicles plus the private vehicle collisions that result in workers' compensation injuries.*
- (5) *Total state miles is sum of miles from agency-owned vehicles plus miles from agency-driven Motor Pool vehicles.*
- (6) *Rate of Incidents per 12,000 miles is the agency's number of Total Incidents divided by the agency's Total State Miles, and then multiplied by 12,000.*
- (8) *Collision Cost per 12,000 miles is the agency's Property, Liability, and WC cost (from vehicle collisions) divided by the agency's Total State Miles, and then multiplied by 12,000.*

"High Mileage" agencies are those with at least 50,000 in total miles, state plus private. (Private miles are not shown.)  
If a "High Mileage" agency falls below 50,000 two years in a row, it goes on the "Low Mileage" list.
