This Participating Addendum adds the State of Nevada (hereinafter "Participating State") as a Participating entity to purchase from the WCSA Price Agreement, Number 9950, with the entities listed on attached schedule A (hereinafter "Contractor").

1. Scope: This addendum covers Nationwide Vehicle Rental Services within the scope of the WCSA Master Agreement for State Agencies and Political Subdivisions.
2. Changes:
  - 2.1 In-State - Nevada Motor Pool overflow requirements, (the need for vehicles when Motor Pool is unable to provide vehicles to state travelers):
    - 2.1.1 Motor Pool will contact Contractor to set-up the reservation for the traveler at the Las Vegas, Reno and Carson City Motor Pool facility locations.
    - 2.1.2 Once the traveler has picked up the vehicle a duplicate rental agreement **must be provided to the State Motor Pool immediately.**
    - 2.1.3 After the vehicle is returned to the Contractor's location **close out documentation must be provided to the State Motor Pool.**
  - 2.2 Local governments (as defined in NRS §332.015) are intended third party beneficiaries of any contract resulting from this contract and any local government may join or use any contract resulting from this contract subject to all terms and conditions thereof pursuant to NRS §332.195. The State is not liable for the obligations of any local government which joins or uses any contract resulting from this contract.
  - 2.3 Per Nevada Revised Statutes (NRS) 372 the State, University and Community College System, the Court System, the Legislative Counsel Bureau, and Political Subdivisions (i.e., cities, counties, school districts, etc.) are exempted from sales taxes and **must not** appear on the rental agreement or invoice.
  - 2.4 Any additional driver fees, hourly overtime charges, drop off fees, refueling charges and vehicle license fees will not be included in base rate but if applicable must be clearly identified with the associated costs.
  - 2.5 Rates quoted will not be subject to blackout dates and do not require a minimum rental period. In the event the Contractor provides a vehicle not included in the contract or authorizes a different rate, the terms and conditions of the contract will nevertheless apply. Contractor may periodically decrease and

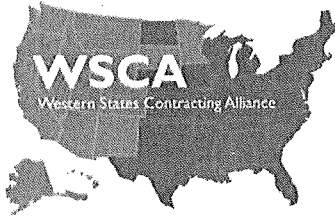
