This Participating Addendum adds the State of South Dakota (hereinafter "Participating State") as a Participating entity to purchase from the Oregon Price Agreement, Number 9949, with Hertz Corporation (hereinafter "Contractor").

1. **Scope:** This addendum covers Nationwide Vehicle Rental Services within the scope of the WSCA Master Agreement for State Agencies and Political Subdivisions. Eligible participants in this agreement include all agencies, institutions, officers, boards, commissions and public universities of the State of South Dakota, and all political subdivisions of the State, including counties, municipalities and public school corporations within the State of South Dakota. The Contractor may, at the Contractor's discretion, extend pricing from this agreement to Indian tribal governments and non-profit organizations in South Dakota. Any sales made to Indian tribes and non-profit organizations from this agreement shall be included in any required reports and shall be subject to the WSCA administrative fee.
2. **Changes:** The State of South Dakota is self-insured for liability coverage. State employees utilizing this contract will provide a Certificate of Coverage provided by the South Dakota Office of Risk Management, verifying state employee liability coverage for \$1,000,000 per occurrence through the Public Entity Pool for Liability (PEPL) Fund (SDCL 3-22).
