Workers' Compensation Claims Characteristics Calendar Year 2020

The Workers' Compensation Division received notification of 21,874 accepted disabling claims in 2020. Employment decreased by 128,300 workers and claims decreased by 532 from 2019, resulting in a 2020 claims rate of 1.2 claims per 100 workers.



In 2020, there were 79 years separating the oldest and youngest workers. The youngest were two 14-year-old workers: a vehicle cleaner who slipped on ice, and a farmworker who drove an all-terrain vehicle off a cliff. The oldest was an 93-year-old cashier who fell over after unintentionally striking a customer with a motorized cart.

Sprains or strains of the back were the most common injury in 2020, accounting for 3,347 claims (15.3 percent).


There were 3,718 accepted disabling claims for falls in 2020. Approximately 74 percent resulted in either sprains, strains, or tears (1915) or fractures (822).

In 2020, 7.8% (1702) claims had an event of "Exposure to other harmful substances, compared to .75% (168) in 2019. In 2020, 1555 (91.3%) of the 1702 were due to Coronavirus exposure.

Bodily condition and/or motion incidents are cases where workers themselves are the primary source of injury or illness, such as a worker twisting his/her back when reaching for something. These events most commonly result in sprains or strains (approximately 72 percent).

PART OF BODY AFFECTED:



INJURY/DISEASE FACTS, OREGON, 2020

- Private industry accounted for 19,426 of the accepted disabling claims (88.8 percent).
- The most commonly injured worker occupation was transportation and material movers, comprising approximately 18 percent of all accepted disabling claims in 2020.
- Occupational diseases comprised 11.2 percent of the accepted disabling claims.
- Workers in their first year with an employer filed 7,072 claims, or 32.3 percent of 2020 accepted disabling claims where the worker's tenure is known, compared to 2,350 (10.7 percent) for those in their second year.
- Of the total 21,874 accepted disabling claims, 112 were for workers younger than age 18, and 891 were for workers age 65 or older. The average age of claimants in 2020 was 41.
- Most of the claims were for male workers, accounting for 13,255 (60.6 percent) of the total compared to 8,619 (39.4 percent) for females.
- The median weekly wage at time of injury for all claimants was \$726.00 compared to \$863.6 for all Oregon workers, excluding federal employees.
- Of the total 21,874 claims, 2 percent (428) occurred out of state.
