The Office of Licensing and Regulatory Oversight will be sponsoring training related the MDS/RAI changes effective October 1, 2016. The class will be on Tuesday, September 27, 2016. This is a half day class, designed to inform individuals using the Resident Assessment Instrument (RAI) and Minimum Data Set (MDS) process about requirement changes and alterations being made to the MDS tools. These changes are especially pertinent to facilities providing Medicare A skilled services.


