Review of agenda.

Status of EDI Transactions Available for Testing

Discussion of the timeline handout. This timeline starts September of 2008 and goes through December 2008, in all actuality, it started well before September of 2008. It is a high level look at the EDI testing. The 837 transaction has been tested since July of 2008. There are 4 more scheduled transaction testings still to come.

Question: Will the 835 include the MCR transaction?

Answer: No, DHS is working on the MCR Process and should have more details,

The 276/277 is in process but no timeline has been set.

Provider Training Update

More providers have been showing up than were actually registered. No requests from this group have been made for additional trainings. Jon Pelkey mentioned announcing this training at the MCO Contractors meeting on Thursday, October 16th. We will provide training if you have more than 20 people and provide the facility. Currently, trainings are scheduled through December 4th. The training materials are on the DHS website. The DHS Learning Center has an e-course available. If you e-subscribe on the DHS MMIS web site (<http://www.oregon.gov/DHS/mmis/>) you will get an e-mail alert when anything is happening.

MMIS MCO Cutover Calendar

We walked through the calendar and discussed certain dates.

Question: When will the last 835 go out?

Answer: November 14th.

Question: When is the last day to submit provider applications, form DMAP 3108?

Answer: Friday, November 25th, but if we receive them we will hold onto them until Go-Live and will enter them into the new system. Note: if we receive them before cutoff, those providers will get their PIN letter right away.

An updated calendar will be distributed when we get more specific dates and times. Alice recommended reviewing the EDI Overview handout from a previous meeting. We will get this distributed to the group.

Question: When will enrollment of newborns take effect?

Answer: December 9 with an effective date of December 15th.

Status of PIN Contacts

Alice read off the names of the plans that we have received contact information from. We need to have this information within the next 2 weeks.
