## **Public meeting: Statewide health information technology plan**

The Oregon Health Authority is launching a series of six public meetings around the state to gather input on a statewide health information exchange plan. The meetings will be hosted by the Health Information Technology Oversight Council (HITOC).

As Oregon works on lowering the cost and improving the quality of health care, the ability for health care providers to easily and securely share information about patients and treatments gains even more importance. Electronic health information exchange will provide the means for providers to share medical records electronically so the right information is available for patient care when and where it's needed..

OHA and a group of stakeholders drafted a plan that will be released in mid-June so interested parties can provide feedback at the public meetings.

HITOC, stakeholders and the planning team have developed a strategy that includes:

- A phased approach to planning and implementation of health information exchange;
- Oregon Health Authority in a role of facilitation, coordination, communication and oversight;
- Adherence to federal standards and certifications as they evolve;
- Development of Oregon-specific standards, certifications and accountabilities; and
- Local health information organizations collaborating and developing local and regional efforts to provide health information exchange.

Stakeholder engagement is an on-going process that includes surveys, community meetings, webinars, and a strategic workgroup.

Work on statewide Health Information Exchange (HIE) is being funded through the federal stimulus grant. A final report on Oregon's plan is due to the Office of the National Coordinator for Health Information Technology in late August.
