OAR 333 069, Certification of Individuals and Firms Engaged in Lead-Based Paint Activities, requires every firm whose employees conduct lead-based paint activities to be certified by the State of Oregon as a Lead-Based Firm. The Construction Contractor's Board also requires a Lead Abatement Business Endorsement. The lead abatement certified firms agree to only employ certified employees of the appropriate discipline to conduct lead-based paint activities and to follow the lead based paint activities as prescribed in OAR 333 069, paragraphs 0005 through 0090. The State of Oregon does not favor one firm over another and any references herein to any organizations, specific commercial products, process, or service by trade name, trademark, manufacturer, or otherwise, do not necessarily constitute or imply its endorsement or recommendation.
