M.D.S. Version 3.0 officially replaced M.D.S. Version 2.0 effective October 1, 2010. Seniors and People with Disabilities will be presenting a two day basic Resident Assessment Instrument (RAI) /M.D.S. Version 3.0 training course. This course is intended for nursing facility staff **new** to the RAI/MDS process and that are responsible for completion of all or portions of the MDS 3.0 assessment.
