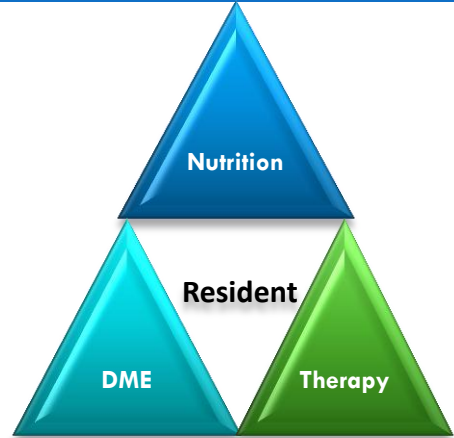
Beth will move you beyond duct tape and pillows and into a whole new “way,” with real tools and real resources for preventing and healing wounds with DME.

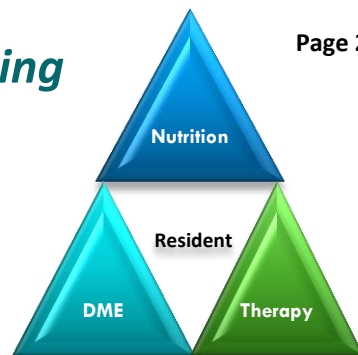
