**This application must be submitted between October 1, 2009 and November 19, 2009.
All returns must be filed by January 19, 2010.**

- Read all instructions (front and back) before completing form.
- Taxes and interest must be paid by January 19, 2010 unless you qualify to make payments.
- File a separate application for each tax program for which you are seeking amnesty.
- You must apply for all tax years/periods for which you are eligible.

Tax return filing instructions

- Include completed returns with this application. Write "Amnesty" across the top of each return.
- If you can't complete the returns by the November 19, 2009 application deadline, you have until January 19, 2010 to file them with the department.
- If you do not meet the deadlines, your amnesty request will be denied.

How to make payments

Once you complete an original or amended tax return for all of the tax years or reporting periods listed on the application, you will need to figure the total amount due. This requires computing the interest on the amount you owe for each tax year or reporting period.

To compute the interest, use the interest calculator at oregontaxamnesty.com.

Program payment options

There are different payment options available for each program.

- Personal income tax: Checking or savings account electronic payment, credit card, check, or money order.
- Transit (TriMet/LTD) self-employment tax: Checking or savings account electronic payment, check, or money order.
- Corporate income/excise, inheritance, estate, and trust: Check or money order only.

Electronic payments from your checking or savings account cannot be used for tax years or reporting periods that began before January 1, 1999. Credit card payments

If you can't pay all of the taxes and interest by January 19, 2010, check the box on the upper right of the application to apply for an installment payment agreement. A department representative will contact you.

If paying by check or money order:

- Make your check or money order payable to "Oregon Department of Revenue."
- Write your daytime telephone number on your check.
- Include your payment and the Form AV payment voucher with your amnesty application or, if you have already sent in your application, mail your payment and voucher to:
