FEES:

PER DIEM FEE: \$1200.00 - **DOCKET FEE:** \$150.00 (Waived if the hearing proceeds as scheduled.)

Grievance, Interest Arbitration, and Fact-finding: The fee is \$1200.00 per hearing day. A hearing day is any portion of a day up to 8 hours. One day per diem charged for each 8 hours spent in preparation, study and writing of the Award and Opinion.

Labor Mediation: \$300.00 per hour, plus travel expenses.

CANCELLATION FEE: If the scheduled hearing is postponed or canceled with less than 14 days notice, the per diem fee for each hearing day scheduled will be charged.

Travel Time: Travel is charged when incurred within the State of Oregon. No charge if travel time is less than four hours in each direction. Travel beyond four hours will be prorated according to the Per Diem

Expenses: Actual cost of reasonable expenses incurred within the State of Oregon to include airfare, car rental, parking, food and lodging. Automobile mileage is charged at the Federal Standard Mileage Rate.
