GIVING ONLINE IS EASY AND SECURE:

- 1) Go to ecfd.oregon.gov and click on “PLEDGE NOW”
- 2) Click “LOG IN” and enter the “iPledgeOnline” giving site by typing in your:
 - » **Username** = your employee ID number, including all zeroes (and begins with “OR” if you work for a state agency).
 - » **Password** = either the password you chose in a previous year OR your first name and last name in ALL CAPS, with no space between (if you've never pledged online before) (example: JANESMITH).

If this is your first time pledging online, you will be asked for your email address and your state agency and location.

- 3) Once logged in, returning Charitable Fund Drive donors can repeat their 2012 pledge automatically, just by clicking “YES” in the “Replicate Your Last Pledge” box and confirming your choices. You can still increase or change your donation amount and add new charity designations.
- 4) Enter your pledge amount, allocate your gift to your charities, and provide contact information.
- 5) Submit your pledge — and you're done! Your gift will start with your first paycheck of 2014.

PREFER PAPER? USE THE PLEDGE FORM ON THE BACK OF THIS BROCHURE!

- Find charities by asking your office's Charitable Fund Drive Coordinator for the 2013 “Giving Guide” booklet. If you don't know who your site's Coordinator is, call (503) 636–4058 to ask.
- You can also find charities by searching online (go to ecfd.oregon.gov, and click on “Pledge Now.”) You do not have to log in, just click “MAIN MENU—charity lookup tool” at the top left of your screen. Also, a spreadsheet of all eligible charities, in alphabetical order, is available at ecfd.oregon.gov.
- If you use the Employee Giving Guide, consult the charity list starting on page 5 to determine the Charitable Fund Drive code numbers for your chosen charities. You can also give a general gift to the Charitable Fund Drive by writing in code #5000.
- Fill out your pledge form completely and be sure to sign it.
- Make a copy of your pledge form for your records.
- Turn in the original of your pledge form, and any cash or check you have donated, to your office's Charitable Fund Drive Coordinator.
- You will receive acknowledgment of your gift via email or US Mail, depending on the contact information you provide.
