CFM® Exam

The State of Oregon will proctor the ASFPM Certified Floodplain Manager exam on July 15, 2009. The exam measures knowledge of a community's responsibilities under the National Flood Insurance Program. The 3-hour, closed book exam consists of approximately 120 multiple choice and true/false questions and requires 2 to 3 hours to complete.

You must apply to Association of State Floodplain Managers (www.floods.org) at least two weeks in advance to take the exam. You are not required to attend the Floodplain Management Refresher Course to take the exam. Workshop attendees should not expect to pass the exam without additional study.
