Notice of Time Extension for Public Comments

Proposal: Oregon LNG Liquefied Natural Gas Terminal and Pipeline

Project Location (portions within Oregon's coastal zone): Clatsop and Tillamook Counties

Comments Due to DLCD: February 16, 2015

Notice is hereby given that the Oregon Department of Land Conservation & Development (DLCD) has extended the period for receiving public comments for the review of the following federal action for consistency with the Oregon Coastal Management Program. The comment period has been extended to **February 16, 2015**.

PROPOSED FEDERAL ACTION: The Coastal Zone Management Act requires that federally licensed and permitted activities that affect the coastal zone must be consistent with approved state coastal zone management programs. LNG Development Company, LLC (d/b/a Oregon LNG) and Oregon Pipeline Company, LLC have applied for authorizations from the Federal Energy Regulatory Commission and the U.S. Army Corps of Engineers for the siting, construction, and operation of a Bidirectional Liquefied Natural Gas terminal in Warrenton, Oregon, and an associated natural gas pipeline crossing through Clatsop and Tillamook counties.

COASTAL ZONE REVIEW CRITERIA: Oregon LNG and Oregon Pipeline have determined that the proposed actions are consistent with the enforceable policies of the Oregon Coastal Management Program (OCMP). DLCD is reviewing this determination and soliciting comments that address the proposed actions' consistency with applicable elements of the OCMP, including:

- Statewide Planning Goals
- Acknowledged Local Comprehensive Plans & Implementing Ordinances
- State Authorities incorporated into the OCMP (*e.g.*, authorities governing Removal-Fill, Air and Water Quality, Fish and Wildlife, and Water Rights), as applicable.

If you believe this project is inconsistent with the Oregon Coastal Management Program, your comments to DLCD should explain why you believe the project is inconsistent and should identify the Oregon Coastal Management Program element(s) in question. You should also describe how the project could be modified, if possible, to make it consistent.
