Based on the discussions at the prehearing conference held on December 5, 2013, and to establish a fair and orderly process for completion of the contested case hearing in this matter, the following Order is adopted:

ORDER

IT IS ORDERED that the parties and limited parties to this case will abide by the following schedules:

1. The parties have until December 11, 2013 to file a response to the petitions for party or limited party status.
2. The parties and potential parties will attempt to agree on stipulated facts for the contested case hearing. The facts that the parties and potential parties agree on will be filed as stipulated facts by December 13, 2013.
3. Any objections to the Notice of Contested Case Hearing must be filed by December 13, 2013.
4. Any facts that the parties or potential parties intend to rely on in their briefs that were not agreed upon in the stipulated facts will be filed by December 17, 2013.
5. All parties and limited parties must file their initial briefs by December 20, 2013.
6. All parties and limited parties must file their responses to the initial briefs by January 3, 2014.

7. Oral argument, if necessary, shall be set at a date after the filing of responses to the initial briefs. I will attempt to find a date that is agreeable to all the parties and limited parties.
8. Hard copies of the pleadings must be filed with hearings officer, but service of the pleadings on the other parties and limited parties may be by electronic message (e-mail).
9. All of the parties and potential parties will provide the hearings officer with a list of all addresses they wish to receive service by electronic message (e-mail). The hearings officer will then establish a list for the parties and potential parties to use for service.
