In order to qualify, an FE must be located in a neighboring state with removal laws substantially similar to Oregon's. Each branch of a registrant's FE is a separate establishment and must be registered as a fixed place of business. ORS 432.317(9); ORS 692.160(a); ORS 692.270 (Once approved, registrations remain valid until surrender, change of ownership or Board action.)

OAR 830-011-0020 Apprenticeship — Generally (3)(a) (a) Apprentice funeral service practitioners will not be accredited for time served in their funeral service practitioner apprenticeship while enrolled in a full-time funeral service education program. For the purpose of this chapter, full-time is considered 12 or more credit hours per quarter. If the apprentice is enrolled in 11 or less credit hours per quarter, he or she will be considered a part-time student and could qualify for a funeral service

practitioner apprenticeship providing he or she can meet the minimum requirements set forth above.
Apprentice funeral service practitioners who are planning to become part-time students must submit a letter to the Board clearly explaining their ability to attend classes and still meet the minimum requirements of this section. The Board will review each request individually based on the submission of all appropriate paperwork, fees and letters of explanation. No credit will be granted for apprenticeship time served unless prior approval by the Board has been granted.
