Re. A request to the board, in the public interest, to authorize a single funeral service practitioner (FSP) to manage more than one Funeral Establishment (FE)

To the Board:

My name is Michael W. Godsey and have held an Oregon State FSP License #2008/2009-FS-0536 since August 5, 2008. My license is current and in good standing.

I work as a general manager with Keystone Group Holdings, Inc. and am employed with Bateman Funeral Home located in Newport, Oregon. I further have administrative responsibility to oversee the manager's role at Pacific View Memorial Chapel located in Lincoln City, Oregon.


The current manager at Pacific View Memorial Chapel has expressed that he no longer desires to serve as manager at that location. Due to the shortage of Oregon licensed funeral directors and the immense slow down of our economy, we are not able to hire a full-time FSP to serve as a manager at the Lincoln City location. It is in the public interest that the funeral establishment operates within the community at Lincoln City, as it has since the 1940's, and there is no other establishment available within 25.9 miles.

The Lincoln City location has a holding facility that is used regularly by the Medical Examiner to examine all ME cases that die in Lincoln County, which is a major advantage for the District Attorney in cost containment. The facility is staffed by a full-time administrative support person that answers the phone and door. When at-need and pre-need funeral arrangements are requested, a director from the Newport facility is dispatched, by appointment, to meet with the families. The current manager is based out of Newport and either he or I will respond to the death care needs of the community. All embalming is done at the Newport location.

In so far as DAR 830-030-0000(9) provides that the Board may authorize a funeral service practitioner (FSP) to manage more than one funeral establishment (FE) when the Board, in its sole discretion, determines that the management of more than one FE by a single FSP is in the public interest, I Michael W. Godsey, FSP License #2008/2009-FS-0536 hereby request that the board grant me privilege to manage more than one FE (not co-located) by basis as described herein. The two locations are: Bateman Funeral Home, 915 NE Yaquina Heights Drive, Newport, Oregon and Pacific View Memorial Chapel, 560 SW Fleet Avenue, Lincoln City, Oregon.

I look forward to your favorable acceptance of this request.

RE: Request to manage more than one facility

Michael Godsey, FS-0536, current manager of Bateman Funeral Chapel in Newport (FE-8638, "Bateman's"), is requesting that the Board grant him authorization to simultaneously manage Bateman's and Pacific View Memorial Chapel in Lincoln City (FE-8639, "Pacific View"). Pacific View's manager on the Board's records is Richard Woolslayer (CO-3818). Both facilities are owned by Keystone America, Inc. are approximately 26 miles apart.

Please review his attached letter. In summary, Godsey's stated that the current manager, Richard Woolslayer (CO-3818) "has expressed that he no longer desires to serve as manager of [Pacific View]."

In his request to simultaneously manage both facilities, Godsey points to the public's interest - because the corporation cannot afford to employ a full-time manager at Pacific View, which is currently the only funeral establishment in Lincoln City, so unless he can manage both, they would have to close Pacific View.

In addition, while both facilities use the prep room at Bateman for embalming and preparation, the Medical Examiner uses Pacific View's holding room to conduct autopsies, saving the Lincoln County money because, if there were no funeral establishment in Lincoln City, the ME would have to travel to Newport.

Currently, an administrative secretary is employed at Pacific View for walk-ins and calls, and she contacts the funeral service practitioners at Bateman to meet with the family to make arrangements at either Bateman or Pacific View.
