

## CHAPTER 811 DIVISION 10

### Definitions

**811-010-0005** As used in OAR Chapter 811 unless otherwise required by context:

(1) "Applicant" or "Subject Individual"

(a) "Applicant" means a person applying for a license to practice chiropractic in this state, or applying for certification as a chiropractic assistant in this state

(b) "Subject individual" means a person from whom the Board may require fingerprints for the purpose of enabling the Board of Chiropractic Examiners to request a state or nationwide criminal records check. Under this chapter, subject individual means applicants for doctor of chiropractic license, chiropractic assistant certification, and any licensee under investigation as ordered by the Board.

~~(1)~~(2) "Chiropractic Physician" means a physician licensed to practice Chiropractic under the provisions of ORS 684.040.

(3) "Patient" means any person who is examined, treated, or otherwise provided chiropractic services whether or not the person has entered into a physician/patient relationship or has agreed to pay a fee for services.

~~(2)~~(4) "Advertising" means any form of promotional (educational) information.

~~(3)~~(5) "Food" means nutritive material taken into an organism for the growth, work, or repair and for maintaining the vital processes; anything that nourishes or sustains.

~~(4) "Patient" means any person who is examined, treated, or otherwise provided chiropractic services whether or not the person has entered into a physician/patient relationship or has agreed to pay a fee for services.~~

(6) "Good moral character" means: an applicant or subject individual who has not:

(a) committed an offense or crime involving moral turpitude;

(b) committed an act or crime involving dishonesty, fraud, deception, misrepresentation, gross negligence or incompetence;

(c) had a professional license revoked or suspended by this state, a political subdivision of this state, or a regulatory board in another jurisdiction in or outside the United States, or voluntarily surrendered a professional license in lieu of disciplinary action;

(d) displayed evidence of an existing and untreated drug, alcohol, or mind altering substance dependency;

(e) been subject to academic probation, expulsion, and/or disciplinary action in an acad

(7) "Nutritional Supplement" means vitamins, minerals, herbs, meal supplements, sports nutrition products, natural food supplements, and other related products used to boost the nutritional content of the diet.

(8) "Over-the-counter" and "Nonprescription drugs" means substances which may be sold without a prescription and which are prepackaged for use by the consumer and labeled in accordance with the requirements of the statutes and regulations of this state and the federal government.

(9) "Prescription drug" or "legend drug" means a drug which is:

(a) Required by federal law, prior to being dispensed or delivered, to be labeled with either of the following statements:

(A) "Caution: Federal law prohibits dispensing without prescription"; or

(B) "Caution: Federal law restricts this drug to use by or on the order of a licensed veterinarian"; or

(b) Required by any applicable federal or state law or regulation to be dispensed on prescription only or is restricted to use by practitioners only

**811-010-0015** Each ~~person holding a license to practice Chiropractic in the State of Oregon under the laws administered by this Board shall file provide~~ their ~~proper and current business address or their and~~ mailing addresses, ~~including all practice locations if they are not currently in practice,~~ with the Board ~~at its office.~~ Each individual ~~Licensees~~ shall immediately notify ~~this the~~ Board in writing ~~at its office address~~ of any change ~~in mailing or business address,~~ giving both the old and the new addresses within 30 calendar days.

### **Display of License and Certificate of Registration**

**811-010-0025** Each ~~licensee person holding a license to practice Chiropractic in the State of Oregon under laws administered by this Board~~ shall display a current the license annual certificate of registration in a conspicuous place in ~~hisany practice location principal office, place of business, or place of employment.~~ A chiropractic physician shall also display their license in a conspicuous location within their principal place of business or employment. ~~The yearly certification should be on display with the license certificate.~~

### **Duty to Report**

**811-010-0040** (1) It shall be the duty of every licensee to file a complaint or notify the Board's Executive Director or designated staff administrative office or any member of this Board of any perceived violation of law or rule, the Act or of these rules in order that the Board may take appropriate investigative and corrective or disciplinary action.

(2) Any person who reports or provides factual information to the Board under this rule and who provides such information in good faith shall not be subject to suit for civil damages as a result thereof.
