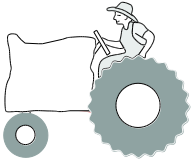


Compare Farm Direct Checks with WIC Fruit & Veggie Vouchers



| Farm Direct Checks | WIC Fruit & Veggie Vouchers |
|--|---|
| Eligible Produce | |
| Locally grown fresh fruits and vegetables | Fresh or frozen fruits and vegetables grown anywhere (Note: Consult market rules if you sell at a farmers' market) |
| Edible blossoms and fresh cut herbs | No edible blossoms or herbs |
| All potatoes | Orange yams and sweet potatoes No other varieties of potatoes |
| Check or Voucher Issuance | |
| Summer season - checks issued once each year between June and September | Monthly, year round - checks issued each month (up to 3 months worth at a time) |
| WIC participant receives a \$20 benefit (five \$4 checks per person) once during the entire season Senior participant receives a \$32 benefit (8 \$4 checks per season) once during the entire season | WIC participant receives a monthly benefit based on WIC category: <ul style="list-style-type: none"> • One \$6 voucher; or • One \$10 voucher; or • One \$10 voucher and one \$5 voucher |
| Rules for Accepting Checks or Vouchers | |
| Checks must be spent with authorized farmers by October 31 st | Vouchers are valid for 1 month and are printed with a "First Day to Use" and "Last Day to Use" |
| Farmer not required to write in purchase price; check denomination is preprinted | Farmer required to write in purchase price even though voucher denomination is preprinted |
| Farmer not required to check ID of shopper; no signature required on check | Farmer must have shopper sign voucher and compare with signature on shopper's WIC ID card |
| Farmer may deposit checks anytime between June 1 st and November 30 th | Farmer must deposit within 60 days of "First Day to Use" |
| Shoppers spend checks only with Farm Direct-authorized farmers | Shoppers spend vouchers at WIC-authorized vendors including grocery stores and farmers |
