For each license fee greater than \$100, thirty percent of the amount of the license fee or \$750 whichever amount is less.

The penalty fee is assessed in addition to the license fee and applies to each license code. For companies with multiple licenses, a separate penalty fee is required for each license code they hold.

**** LATE FEES CAN ONLY BE COLLECTED FOR 1 YEARS WORTH OF LICENSES. THEREFORE, IF YOU ARE OUT COLLECTING LICENSING FEES FOR MULTIPLE YEARS, ONLY THE MOST CURRENT DELINQUENT YEAR CAN BE ASSESSED A LATE FEE(S).**
