My primary concerns are centered a round water quantity. A pressing problem we, as a state and individuals, will face is the availability of sustainable water supplies for future beneficial uses. This hits a number of the core concepts you list in your email: stewardship and responsibility; active management; managing for sustainability; healthy fish and wildlife; healthy communities; future generations. Following are some thoughts for the Committee's consideration: ability to construct reservoirs on forest lands; impacts to water quantity from management practices; on a more local level, an open dialogue with water users whose water sources are on forest lands and whose conveyance systems cross forest lands; cooperative water data collection projects.
