

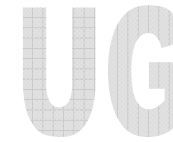

This annual fuel usage form is required for all governmental agencies and special districts as listed under the following sub-sections of ORS 319.831:

- ORS 319.831(e) - any incorporated city or town of this state
- ORS 319.831(f) - any county of this state or any road assessment district formed under ORS 371.405 to 371.535
- ORS 319.831(i) - any rural fire protection district organized under the provisions of ORS chapter 478
- ORS 319.831(j) - any district, as defined in ORS Chapter 198, that is not otherwise provided for in ORS 319.831
- ORS 319.831(k) - any state agency as defined in ORS 240.855

Mass Transit Districts as defined in ORS 267.010 and Transportation Districts as defined in ORS 267.510 are also required to file this form.

INSTRUCTIONS FOR ANNUAL USE FUEL USER TAX REPORT (form 735-1325UG):

The Use Fuel User Tax Report is used to report total Use Fuel consumed. The most common Use Fuel is clear diesel, but use fuel also includes propane, CNG, LNG, biodiesel, and any other combustible gas, liquid, or material (not gasoline) used to generate power to propel a motor vehicle on public roads. Generally, dyed diesel is not reportable as use fuel under Oregon laws because Federal law prohibits the use of dyed diesel to propel vehicles on highways. Dyed diesel should not be included in this report unless the dyed diesel is being used to propel vehicles on the highways, in spite of the Federal prohibition.

WHAT TO INCLUDE IN THIS REPORT:

This report is for licensed Users who are identified as exempt governmental entities or agencies pursuant to ORS 319.831, 267.010 and 267.510. The total number of gallons of Use Fuel consumed for the reporting period is required.

Reporting Period and User Information:

Write in the calendar year for which this report is being prepared. Reports are due (received in the office) on or before January 20th following the end of the report period. Complete the user name, address and license number fields in the header section of the report.

CERTIFICATION OF USER: Sign and date the completed form on the lines provided, and legibly print the name and title of the person signing the form as well as the name and title of the person preparing the report.
