RULE SUMMARY

Chapter 746, Oregon Laws 2007 requires ODOT to adopt rules specifying the process by which a municipality may apply for a grant from the Oregon Streetcar Project Fund. The law authorizes the State Treasurer to issue lottery bonds to finance grants for purchase of streetcars from an Oregon based and Oregon owned company. These rules establish the Oregon Streetcar Project Fund Program, definitions, eligibility standards and application requirements.
