RULE SUMMARY

To tighten security in the process for issuance of driver licenses and identification cards, DMV amended OAR 735-062-0090 to shorten the time period within which a person may apply for renewal to within four months of the expiration date. This created a hardship for some members of the Oregon National Guard or military reservists when the person's driver license or identification card expires while the person is deployed. Because the length of a deployment overseas is approximately 400 days, or just over 13 months, DMV amended OAR 735-062-0090 to authorize renewal up to 14 months prior to expiration of the current license or identification card for a member of the Oregon National Guard or military reservist deployed in defense of our country.
