## SPECIAL USE TRAILER SCHEDULE OF REGISTRATION FEES

Additional information about special use trailers on the back of this fee schedule. Item #2 tells you the correct way to measure a special use trailer. If vehicle is registered in Multnomah County, add the \$112 county registration fee. If the vehicle is registered in Washington or Clackamas County, add the \$60 county registration fee.

## ALL ABOUT SPECIAL USE TRAILERS

1. Special use trailers include trailers of any width that are used temporarily on a construction site for office purposes only and trailers eight feet or less in width used for business or commercial purposes.
2. \$81 is charged for the first 10 feet and \$6.75 for each additional **full** foot measured from the trailer hitch to the rear-most extremity of the trailer. (Any fractions are rounded down to the full foot.) If a special use trailer does not already have a special use trailer plate, a plate fee is also required. Special use trailers are registered for a two-year period. This fee chart will enable you to determine the correct fee.
3. One registration plate is issued. It is to be displayed on the rear of the vehicle.
4. Special use trailers are **not** required to be continuously registered, but must be registered or operated with a valid trip permit, when used over the highways.
5. Any application for title must include the title fee and other applicable fees.
