DMV uses the same address for all vehicles registered in your name **and** for your Driver License, Permit or ID Card. By giving us your new address, we will change the address on:

1. Your Driver License, Permit or ID Card record. If your Driver License, Permit or ID Card is currently valid, we will send an address sticker to your new address. You must place this sticker on your card.
2. Every vehicle registration record where you are the owner and where it is your address being used on the registration.
  - If there are multiple owners and you are not sure whose address is being used, ask all owners to verify that their current address is on file with DMV.
  - We will not send new registration cards. Please write your new address on the vehicle registration card so that it matches our computer records.
